Sub: Minutes of the meeting of Academic Council held on 7.10.2014 and discussion on items arising out of the minutes.

- 1. The draft of exam manual prepared by the Examination Committee comprising Dr. Joseph Moolayil (Chairman), Dr. Samson Davis (Controller), Dr. Cyriac Antony, Dr. Sibi Zacharias, Prof. Johnson John (Deans), Prof. Jose P. Jose (Asst. Superintendent of Exams), Prof. Alphonse Ligori (Staff Secretary), Dr. V. S. Sebastian (Dean, Student Services), and Dr. C.M. Joy (Autonomy Special Officer) as members was presented by Dr. Samson, Controller of Examination. He observed that the manual was prepared sticking to the basic structure and content of the MG University examination manual with necessary modifications (S 116/3-4) as applicable to Sacred Heart College, Autonomous. The manual was unanimously approved by the Academic Council for submission to the Governing Council.
- Approval of Examination Calendar: Examination Calendar of semester I and II (PG and UG) for the year 2014-15 was presented by the Controller of Examination and was approved for submission to the Governing Council.
- Decided to hold the next Academic Council as suggested by the College Council on Saturday, Oct. 18, 2014.

The Examination Manual and the Exam Calendar submitted by the Academic council was approved by the Governing Council in its meeting held on 8.10.2014, the same was submitted to the Mahatma Gandhi University on 13.10.2014 for its approval.

NOTE TO THE ACADEMIC COUNCIL

Item No. 2

Sub: Admissions: Regulations regarding admission of students – Admission Committee (108/ii – p. 46) – ratification of the process of 2014; constitution of Admission Committee to study and present a proposal in the next meeting.

The admissions to the UG programmes in the autonomous stream for the academic year 2014-15 was conducted as per the Centralized Admission Process (CAP) of the Mahatma Gandhi University due to the delay in the award of Autonomous status to Sacred Heart College by the University Grants Commission. Students were admitted as per the affiliating university rank list, strictly adhering to rules and regulation regarding reservation and merit. All the students and parents submitted an undertaking showing their willingness to join the programme under autonomous scheme.

The admissions to the PG programmes in the autonomous stream for the academic year 2014-15 was conducted by the college with the permission of Mahatma Gandhi University, strictly following the rules and regulations stipulated by the Government of Kerala and MG university.

Postgraduate Admissions-2014

The admissions to various Post Graduate (PG) programmes for 2014-16 were conducted as per the prospectus of the College, designed in tune with the MG University pattern. Notifications for admissions were published on 10th August in five leading newspapers and on the college website. An application fee of Rs.200/- and Rs.100/- respectively were charged on from general and SC/ST categories of applicants. The trial rank list was published on 15th and the final rank list on 19th of August. Admissions were conducted on 20th of August. The classes formally started on 25th of August 2014.

The following are some of the important recommendations of the admission section:

Separate prospectus for admissions to UG and PG courses shall be prepared

• For PG admissions an entrance examination (using OMR sheets) may be conducted by the respective departments

• For calculating index marks, 50 % weightage may be given for entrance examinations and 50% weightage for the CGPA of core courses at the end of the fifth semester.

The matter is placed before the Academic Council for ratification of the action of the Principal.

The Academic Council may constitute an Admission Committee for the academic year 2015-2016 to study and present a proposal in the next AC meeting.

Sub: Syllabus: Approval of syllabus for the UG and PG programmes- admissions 2014.

Due to the delay that took place in obtaining permissions from the various statutory bodies regarding the autonomous status to the college there were serious constraints in preparing a new syllabus or revising them for the programmes offered during 2014-15. Hence the Principal adopted the Syllabus followed by the affiliating university for the timely start of all programmes, on the recommendation of the various BOS, which in their initial sitting approved the MG university syllabi of 2009 for the 2014-15 admissions. The Council also resolved to implement CBCS system for all UG programmes and elective system for all P G programmes.

The syllabus approved by the BOS of various subjects in its meetings for the admissions 2014-15 of UG and PG programmes is appended.

Academic Council is requested to approve the recommendations of the BOS which is placed before it separately.

Sub: Indirect Grading (Marks system) to PG course evaluation as in the UG programmes– proposals from Board of Studies.

Mahatma Gandhi University has adopted Mark System (indirect grading) since 2013 in its UG programmes. However, the PG programmes continue to have direct grading system for the examinations with weightage in the question papers. University may change the PG weightage system to Mark System soon. In order to bring in uniformity in assessment procedures, indirect grading (mark system) may be adopted at PG level as well.

The Academic Council has to approve the recommendations of the BOS which are placed separately.

Hence, the matter is placed before the Academic Council for approval.

Sub: Research Advancement – UG, PG, Post PG (Doctoral) levels - Note for discussion

Undergraduate Research Programme

The key component of the undergraduate research programme is the research component where students conduct a two-week research project/ internship with a faculty member as guide, at Sacred Heart College itself or at the place where the student undertakes the internship. During the research period, students prepare research reports, scientific reports and present their research at the end of the fifth semester. Students will be encouraged to give oral and paper presentations at outreach initiatives and conferences. They are also expected to submit a 25 to 40-page project report at the end of the fifth semester.

Postgraduate Research Programme

Students in the Post graduate programme will have to undertake a three-week internship or research work at an industry or at Sacred Heart College during the beginning of the third semester. Under the guidance of their mentor students learn how to carry out experiments in the laboratory or in the industry and develop skills to analyze scientific literature and overcome challenges that cannot be anticipated in a classroom environment. At the conclusion of the programme, students are expected to present their results in a conference / journal or present their research in a poster session. They are also expected to submit a dissertation of 30 to 50 pages at the end of the third semester.

Ph.D Programmes and Research

All faculty without Ph.D should be encouraged for research, leading to Ph.D. Ph.D holders should become the research guide and should avail externally funded projects. Faculty should be

motivated for the above programmes. Proposals in this connection have to be charted out and implemented by the Academic Council.

- 3. Extra Credits for students in the UG programmes

To encourage advanced and industrious learners, credits of more than the stipulated number of credits (120 credits for UG programmes) may be awarded for extra work in a course/activity and shall be counted as *Extra Credits*. The total extra credits that can be earned by a student shall be limited to ten during a programme. Permission for obtaining such extra credits is limited and shall not exceed four credits per semester which shall be done only under the supervision of a faculty member/expert of the institution duly approved by the Department Council. The faculty member in charge shall evaluate the performance of the students and shall forward the Grade sheet of such students to the Controller of Examinations. The list of enrolled students for such courses/activities shall be approved by the principal before the commencement of such courses. All such courses

shall be conducted after the instructional hours of the college. Extra credits are not mandatory for awarding a degree.

The meeting decided to authorize the various departments to conduct suitable value added and add- on courses from the academic year (2014-15) onwards. Principal also suggested that the syllabus revision should take into account the inclusion of issues like human values and environment and sustainability, which are part of our vision and mission. He added that contemporary concerns like gender, inclusivity, equity and professional ethics should find place in the syllabi.

A student can earn one credit per semester by participating in any advanced course offered by the department. The duration of the programme shall be a minimum of 30 hours per semester. The maximum credits for this shall be limited to two during a programme.

Extra Credits can be awarded to the students, for undergoing vocational training in any field. The student shall attend two hours per week in a semester to earn a credit. The maximum credits for this shall be limited to two during a programme.

The student enrolled for **NCC/NSS** shall be present for at least three hours per week for training programmes as prescribed course for these activities. When they complete four semesters (Total 150 hours), it can be treated as three credit courses. This programme may be funded by UGC in its special scheme.

For credits in **Physical Education**, the student shall be present at least three hours per week (45 hours in a semester) for participation in games and sports activities. These shall be carried out outside the class hours and carries one extra credit each which shall be limited to four credits during a programme.

For awarding one extra credit in co-scholastic activities such as music, dance, theatre, social fora etc. the student shall actively involve in the activities of such groups under the leadership of a faculty member. The minimum hours expected to be spent is 50 hours for

a particular activity for earning a credit. The maximum credits that can be earned under this category is two.

A committee may be constituted by the Academic Council for the preparation of a draft proposal for 2015-16.

MINUTES OF THE ACADEMIC COUNCIL - No. 2

Hadrian Hall Oct. 18, 2014 Saturday 10 am

Meeting began with a prayer led by Fr. Principal.

The AC secretary reported leave of absence: Mr. C.J. George, Mr. Venugopal C. Govind, Dr. George Peter Pittappilly CMI.

Others members absent: Mr. Jose Dominic

Principal welcomed the members and introduced all those who were present to the gathering. In his preliminary remarks, he stressed the need to ensure that the system was flexible and responsible.

The relevant texts from the ordinance regarding the functions and powers of Academic Council were read out.

His proposal that email be used for ordinary communication was accepted by the council members. However, for formal meetings, regular mail shall be used.

Agenda item No. 2: The procedure adopted for the UG and PG admissions 2014-15 was presented by Dr. Cyriac Antony, Admission Committee Chairman and was approved.

> It was decided to constitute an admission committee with Dr. Cyriac Antony as its chairman to prepare a comprehensive proposal regarding UG and PG admissions for the academic year 2015-16, ensuring compliance with the university and state regulations, and to circulate the same among the academic council members by email.

Agenda item No. 3: The Academic Council accepted the nominations of two experts to each of the various Boards of Studies, presented by the departments concerned.

Agenda item No. 4: The syllabi for UG and PG programmes for the batch of 2014-15 admissions, presented by the respective Boards of Studies, were approved.

Agenda item No. 5: The proposal of the various Boards of studies to introduce indirect grading (marks-based evaluation) in PG course evaluation as is being done in the UG programmes, was approved.

Agenda item No. 6: The recommendation of the various Boards of studies to fix continuous assessment component to be uniformly 25% of the total for the UG and PG programmes was approved.

In addition:

- Resolved to fix a separate minimum score of 30% for both the Continuous Assessment and the End Semester Assessment components, and aggregate minimum of 40%.
- Resolved to adopt the seven-point scale based on the total percentage of marks for all courses (theory and practical) with A+ (outstanding) as the highest Grade (with grade point 9 or above) and F (failure) as the lowest Grade (with grade point 4 or below). Candidates who secure E grade and above will be eligible for higher studies.

Agenda item No. 7: The various forms for evaluation presented by the IQAC were approved.

Agenda item No. 8: Decided to constitute an academic audit committee comprising external experts in the Science and Humanities/Commerce streams under the auspices of IQAC.

Agenda item No. 9: Research Advancement

Resolved to instruct the various Boards of Studies to give due consideration to the following components in designing/re-designing their programmes.

- 1. Orientation in Research Methodology as suited to UG/PG levels.
- 2. Internship with industry as part of the training resulting in a research project report.

- Forging tie-ups with industry with faculty involvement to ensure industry-readiness of students.
- 4. Group projects to promote social relevance of learning.
- 5. Interdisciplinary approach in designing curriculum.
- 6. Grace marks for sports and arts performance, as per the university guidelines.

Agenda Item No. 10 – New Programmes

- Resolved to entrust the Board of Studies of Sociology to study the feasibility, employment potential and prepare a syllabus for M.A. in Sociology in the light of the proposal by the Governing Council.
- Resolved to constitute an inter-disciplinary committee to study the feasibility, employment potential and prepare a syllabus for M. Sc in Environmental Science. NEERI, NIO, NIT Hyderabad.

Agenda Item No. 11 General Discussions and Decisions

- Decided to entrust the Principal to constitute a committee to design a scheme for awarding extra credits to activities like extension, outreach, talent development and other co-scholastic activities.
- Decided to include NCC training to provide additional credits as would fit in the scheme of autonomy.
- 3. The admission committee may look into giving weightage to SH college students in PG admissions, and to SH institution students in UG admissions and make recommendations, while ensuring that the Sports and Arts based merit as well as quotas.
- 4. The committee has to prepare a proposal incorporating all this and present the same for the consideration of the next Academic Council.

Recommendations

- The council resolved to make an appeal to the government to provide supportive grants.

Review of Autonomy

- All statutory bodies have been formed and have started functioning regularly, viz., Governing Council, Academic Council, BoS (20 nos), and Finance Committee. Except for UGC representatives to GC, all other nominations on the part of Government and University have been obtained. So far two governing council meetings, two Academic Council meetings, two Finance Committee meetings and at least one BoS meeting of each board were held.
- 2. The Exam manual was duly submitted. The exam was conducted with some amount of strain but was nevertheless flawlessly accomplished. It was a great feat to conduct the exams almost totally in accordance with the plan and bring out results in time.

- It was found that the expenditure involved in the conduct of exams far exceeded the income generated through exam fees. The matter was presented before the PTA general body, and it has agreed to a reasonable hike in the fees to accomplish the task wef. 2015-16 academic year.
- 4. It is also proposed that the Academic Council makes a recommendation to the authorities concerned to a) permit the college to fix exam fees at a level that would make the conduct of exam without financial loss and b) request the state to provide some special grants for the promotion of autonomy in aided colleges, especially for the conduct of examination.
- University has constituted a high-power committee to monitor the functioning of Autonomous colleges and has articulated a consensual understanding on identified areas of operation.
- 6. Some strain is felt by the teachers on account of new tasks like that of identifying question paper setters, external examiners, designing curriculum and syllabus and the overlapping of routine tasks of examination by the University.

- Committee constituted for academic audit Science and Humanities/Commerce entrusted with – IQAC - Internal audit taking place to culminate in the annual planning exercise being held on March 30-31. External academic audit will be done in June with experts as Dr. Babu Joseph and Dr. Joseph Injodey for Science and Humanities respectively. A three-member team will do the audit with representatives of IQAC and a subject expert nominated by the principal from a panel of 3 proposed by the department.
- Inter disciplinary committee constituted to study the feasibility, employment potential and to prepare a syllabus for M.Sc. Environmental Science. – A committee comprising Dr. James T. CURRICULUM

1.1 SCOPE

Applicable to all regular Undergraduate programmes conducted by Sacred Heart College (Autonomous) with effect from 2015-16 admissions.

1.2 STUDENT ATTRIBUTES

After completing a UG programme from Sacred Heart Autonomous College, students should be able to acquire the following general traits: Intellectual competence, physical and mental wellbeing, spiritual maturity, moral uprightness and secular outlook.

Students should also be able to acquire analytical skills for employment in various professions, ability to access global information and manage such information in their analysis, the skills to use computers, oral communicative skills, awareness of socio-economic issues as well as to promote entrepreneurship and leadership abilities. They should foster a sense of discipline, efficient time management and resourcefulness in problem solving.

1

1.3 DEFINITION.

1.3.1. *'Programme'* means a three-year programme of study and examinations spread over six semesters, according to the regulations of the respective programme, the successful completion of which would lead to the award of a degree.

1.3.2. *'Semester'* means a term consisting of a minimum of **450** contact hours distributed over 90 working days, inclusive of examination days, within **18** five-day academic weeks.

1.3.3. 'Academic Week' is a unit of five working days in which distribution of work is organized from day-one to day-five, with five contact hours of one hour duration on each day. A sequence of 18 such academic weeks constitutes a semester.

1.3.4. *'Common Course I'* means a course that comes under the category of courses for English and *'Common Course II'* means additional language, a selection of both is compulsory for all students undergoing undergraduate programmes.

1.3.5. 'Core Course' means a course in the subject of specialization within a degree programme.

1.3.6. 'Complementary Course' means a course which would enrich the study of core courses.

1.3.7. *'Open Course'* means a course outside the field of his/her specialization, which can be opted by a student.

1.3.8. 'Additional Core Course' means a compulsory course for all Undergraduate students (as per the UGC directive) to enrich their general awareness.

1.3.9. 'Additional Course' is a course registered by a student over and above the minimum required courses.

1.3.10. '*Credit'* is the numerical value assigned to a course according to the relative importance of the content of the syllabus of the programme.

1.3.11. 'Additional Credit' is the numerical value assigned to Club activities, Social service, Internship etc. which is not added with the total academic credits of the students.

1.3.12. 'Internship' is job training for professional careers.

1.3.13. *'College Coordinator'* is a teacher nominated by the College Principal to co-ordinate the continuous evaluation undertaken by various departments within the college.

1.3.14. 'Department' means any teaching department in a college.

1.3.15. 'Parent Department' means the department which offers core courses within a degree programme.

1.3.16. 'Department Council' means the body of all teachers of a department in a college.

1.3.17. *Department Coordinator'* is a teacher nominated by a Department Council to coordinate the continuous evaluation undertaken in that department.

1.3.18. *'Faculty Advisor'* means a teacher from the parent department nominated by the Department Council, who will advise the student in the choice of his/her courses and other academic matters.

1.3.19. 'Grace Marks' shall be awarded to candidates as per the University Orders issued from time to time.

1.3.20. 'Grade' means a letter symbol (e.g., A, B, C, etc.), which indicates the broad level of performance of a student in a course/ semester/programme.

1.3.21. **'Grade point'** (GP) is the numerical indicator of the percentage of marks awarded to a student in a course.

Words and expressions used and not defined in this regulation shall have the same meaning assigned to them in the Act and Statutes.

1.4. DURATION

The duration of U.G. programmes shall be 6 semesters

The duration of odd semesters shall be from June to October and that of even semesters from November to March.

A student may be permitted to complete the Programme, on valid reasons, within a period of 12 continuous semesters from the date of commencement of the first semester of the programme.

1.5. REGISTRATION

The strength of students for each course shall remain as per existing regulations, except in case of open courses for which there shall be a minimum of 15 and maximum of 75 students per batch, subject to a marginal increase of 10. For non-core compulsory courses, the student strength shall be decided by the Academic Council of the College from time to time.

Those students who possess the required minimum attendance and progress during a semester and could not register for the semester examination are permitted to apply for Notional Registration to the examinations concerned enabling them to get promoted to the next semester.

1.6. SCHEME AND COURSES

The U.G. programmes shall include (a) Common courses I & II, (b) Core courses,

(c) Complementary Courses, (d) Open Course (e) Additional core course. (f) Study tour

(g) Internship for select programmes.

Additional credit components

(a) Talent & career club activity (optional)

(b) Social service (mandatory)

(c) Internship English copy editor, Commerce, Communication and Computer applications (mandatory).

(d) Internship (desirable for other programmes).

1.7. EXAMINATIONS.

The evaluation of each course shall contain two parts:

(i) Continuous Internal Assessment (CIA)

(ii) End-Semester Examination (ESE)

The internal to external assessment ratio shall be 1:3, for both courses with or without practical. There shall be a maximum of 75 marks for external evaluation and maximum of 25 marks for internal evaluation.

1.8. Computation of Grade and Grade points.

For all courses (theory & practical), grades are given on a 07-point scale based on the total percentage of marks. *(CIA+ESE)* as given below.

1.8.1 Computation of SGPA

The SGPA is the ratio of sum of the product of the number of credits with the grade points scored by a student in all the courses and the sum of the number of credits of all the courses undergone by a student in a semester.

SGPA (Si) = $\sum (C_i \times G_i) / \sum C_i$

Where C_i is the number of credits of the ith course and G_i is the grade point scored by the student in the ith course.

1.8.2 Computation of CGPA

i. The CGPA is also calculated in the same manner taking into account all the courses undergone by a student over all the semesters of a programme, i.e.

 $CGPA = \sum (Ci \times Si) / \sum Ci$

Where Si is the SGPA of the ith semester and Ci is the total number of credits in that semester. Note: The SGPA and CGPA shall be rounded off to 2 decimal points and reported in the transcripts.

Candidate secure E grade and above will be eligible for higher studies.

Grievance Redressal Mechanism

1. P.G admissions

Zoology, Botany, Aquaculture, Industrial Fisheries are eligible for admission to M.Sc course in Aquaculture and Fish Processing, it is suggested that the entrance examination to this post graduate course may be divided into two parts. NOTE OF THE BOARD OF STUDIES - CHEMISTRY

The meeting held on 16.03.2015 discussed the draft of the revised syllabus for BSc Chemistry programme, CBCSS of both core and complementary courses and approved the same with minor modifications. The revision was done without changing the existing frame work of the programme.

The meeting approved the following.

 To maintain the internal external ratio as 1:3 for both theory and practical courses. Accordingly, the mark for theory is 20:60 and for practical it is 10:30.

- The name of the courses changed to general names viz, Theoretical Inorganic Chemistry, Inorganic Chemistry, Organic Chemistry and Physical Chemistry. There are Open Course and core Elective.
- To include an additional core course on environment science of 4 credit in the second semester.
- 4. The total credit for B.Sc. programme including the Environment Science is 124.
- 5. One credit shall be given for visiting any research Lab/ Chemical industry during the VIth semester and it is mandatory for awarding the degree. The student should submit a report towards the end of the VIth semester. But it is not counted for calculating the grade. Including this the total credits become 125.
- 6. The minimum marks for PG programme should be 40% for both internal and external.
- Regarding extra credit courses, each student should do Social work for 20 hrs of credit 2, which is mandatory and club activities for 2 credits which is not mandatory.
- 8. Students can acquire 2 extra credits by doing an internship programme in research labs/Industrial training programme in a reputed industry, for a minimum of 30 days, and submit a report which is attested by the concerned authority. The same can be treated as equivalent to the project which is to be submitted in the VIth semester.
- Another extra credit course given to the students is training in virtual lab experiments with credit 2.
- 10. To start the revision of PG syllabus and implement from 2016 admission onwards.

The meeting of BoS in Commerce held on 1 st November, 2014 at Commerce Department decided to restructure and revise the syllabus of various courses in the UG programme in commerce for admissions from the academic year 2015 -16. The extent of syllabus revision in each course will be decided by the expert committee constituted for the syllabus revision. 5 committees were

constituted for the revision of syllabus in the UG programme. Accordingly, the following restructuring and syllabus revision were effected in the UG programme.

- The first semester B.com common core 'Perspectives and Methodology of Business Studies' is replaced with 'Business Environment'.
- The fifth semester B.com complementary course 'Advertisement and Sales Promotion' is replaced with 'International Financial Reporting Standards'.
- The second semester B.com 'Corporate Regulations and Governance' has been fully revised to include the new provisions of 'The Companies Act 2013' replacing the earlier Companies Act 1956.
- Additional core course 'Environmental studies' as per UGC stipulation is included.
- Syllabus in the 16 courses of the B.com programme were revised to the extent of 10 to 20
 percent of the existing syllabus incorporating the latest theoretical developments as well
 as newly created knowledge in the relevant fields.
- Total credit assigned to Open Course in the fifth semester was reduced from 4 to 3 and the credit one taken was added to the credit of core course 'Business Management' that comes in the third semester B.com; thereby credit of this core course is raised from 2 to 3.
- Repetition of topics in the current syllabus of various courses in the UG programme was identified and care has been taken to avoid such repetition of topics in the revised syllabus.
- Rearrangement of the existing modules of some courses in a sequence and rearrangement of courses to be taught in different semesters were also made.

NOTE OF THE BOARD OF STUDIES - COMMUNICATION

BOS in communication held on 1.11.2014 has approved the following changes in the UG and PG courses.

Through revising the existing syllabi, the Board of Studies aims to:

- We intend to have a smooth transition to the more structured and skills-driven learning, through stages. Current syllabi of all the courses are incoherent with the evolving demands of the industry.
- Media industry is practice-oriented and to cater to this demand, we propose an unbiased 50:50 mark distribution instead of the current 75:25 mark distribution. Practice as pedagogy, enhanced with continuous and comprehensive evaluation throughout the period is very essential to create sound professionals.
- 3. The curriculum will be designed to enable the students to acquire a critical understanding of key debates in the discipline of media studies and apply theoretical approaches to specific texts, instances or practices. The current syllabi pattern practiced across the state fail to deliver strong orientation towards research. It does not promote in-depth analysis and appreciation of various media.
- 4. Current syllabi are poorly fragmented and create ambiguities. There is no scope for specializations. Students are deprived of opportunities to pursue their areas of interest, since the core area is scattered throughout the curriculum. This increases their workload and adversely affects their productivity and progress.
- 5. As the first stage of revision, all programmes BA Animation and Graphic Design, Master of Communication and Journalism (MCJ), MA Cinema and Television, MA Graphic Design and MA Multimedia shall be undergoing essential changes that would effectively prevent errors in implementation of the core concepts in existing syllabi. This revision caters only to immediate defects which are already identified and preventive treatment devised.
- Basic changes which would represent shifts in perspective, content and form shall be finalised in the next stage of revision expected to be implemented from 2017.

NOTE OF THE BOARD OF STUDIES - ECONOMICS

The meeting of BoS in Economics held on 1st November, 2014 at Economics PG Library Hall decided to restructure and revise the syllabus of various courses in the UG programme in Economics for admissions from the academic year 2015-16. The extent of syllabus revision in each course will be decided by the expert committee constituted for the syllabus revision. 15 committees were constituted for the revision of syllabus in the UG programme. Accordingly following restructuring and syllabus revision were effected in UG programme.

- Economics Department replaced the first semester BA Economics core paper 1-"Methodology of Social Sciences with Special Reference to Economics" with "Historical Perspective of Economic Thought".
- Syllabus in the remaining 14 core courses of the BA Economics programme was revised to the extent of 10 to 20 percent of the existing syllabus incorporating latest theoretical developments as well as newly created knowledge in the relevant fields.
- Total credit assigned to Open Course (in the 5th semester) was reduced from 4 to 3 and the one taken was added to the credit of Core 7 Quantitative Techniques for Economic Analysis with 108 teaching hours (in the 5th semester), raising its credit to 5.
- 4. Repetition of topics in the current syllabus of various courses in the UG programme was identified and care is taken to avoid such repetition of topics in the revised syllabus.

NOTE OF THE BOARD OF STUDIES - ENGLISH

BoS in English held on 01.11.2014 approved the revision of the syllabus with the following changes in the UG Programme.

BA English (Copy Editor) is a semi-vocational undergraduate programme. It is a generic programme that is foundational to Master's degree in English Language and Literature, Mass Communication, Journalism, besides other disciplines such as Business Administration, Personnel Management etc. The vocational content of the programme equips the students to find placements in publishing houses as content writers, editors, lay-out artists as well as entrepreneurs in publishing industry. The programme consists of 4 Common Courses (Language 1 - English), 2 Common Courses (Language 2); 14 Core Courses; 4 Vocational Courses; 4 Complementary Courses and 2 Open Courses.

While revising the syllabus and curriculum, the Board of Studies has attempted to bring about a balance between the academic and vocational contents of the programme. While on the one hand, the literature courses have been enriched by incorporating more recent trends in literature, the approaches to the study of literature have been made more engaging by introducing applicational modules. It demands of the students to apply the approaches, methodologies and skills they have acquired through the theoretical modules of the course work.

The vocational content consists mainly in the use of information and communication technology vis-à-vis printing and publishing. Taking cognizance of the fast-changing nature of the technology and its applications, the board has, after detailed deliberations, introduced modules that are likely to remain in long term use. One of the highlights of the course work is that, apart from bringing out an in-house journal, the students are required to undergo a 21-day internship with the leading media/ publishing houses and are required to submit a report of the training undergone.

It is believed that the revised syllabus addresses the manifold challenges of an undergraduate programme of this kind. While it opens the portals of academic pursuit in a variety of disciplines, it also equips the students to undertake jobs on completing the programme successfully.

Details of the syllabus revision in UG Complementary programme in History

The meeting of the BoS in History was held on 1st November, 2014 in the Economics Department and decided to restructure and revise the syllabus of the Complementary Course in History for the UG programme in Sociology and Economics. The Expert Committee recommended a thorough change in the syllabus. The Syllabus aimed to make the students competent enough in the various developments in the world and also in the Indian culture related to the Modern Period.

In the First semester, students are expected to do a thorough analysis on the various developments that took place in the world scenario under the course title of 'Historical Currents of the Modern World' instead of the Roots of the Modern World. This course intends to give a brief and general idea on the origin of the modern world and the force and the course of the developments in different parts of the world. This course explains the trials and turbulences and transitions that the world had experienced over the years and analyses the problems of the present-day world developments. It also traces the growth of the fundamental principles that

took place in the world by various factors and events. This will support students to kindle a spirit of enquiry more about the various progress and developments of the world.

In the Second semester, students are expected to deal with modern India under the course title 'The Concise History of Modern India' instead of the 'Transition to the Contemporary World'. In this semester, students are asked to do their historical understanding on the various improvements that took place in Indology. This will provide a better understanding about the evolution of Indian culture from colonization to decolonization.

After the first two semesters students will have a better perception in their analysis about the current issues related to the cultural heritage of India and the World. The students will have a better competency in the various types of examinations at the national level.

The meeting of the Board of Studies of Sociology held on 1-11-2014 reviewed the existing syllabus in both UG and PG and evaluated the efficacy of it in the wake of autonomy. The Board has decided to make some alterations in the existing curricula for U G Programme to make it more student friendly and academically relevant.

Existing 9 courses such as Methodology and Perspectives of Social Sciences, Essence of Sociology, Social Stratification, Environment and Society, Culture and Personality, Industry and Society, Crime and Society, Gerontology, Tribal Society in India are changed. Some of these courses have been completely avoided, and some other courses such as Tribal Society in India and Social Stratification and Essence of Sociology have been reformulated by adding some new topics and slightly altering some other topics.

The newly introduced titles are: Fundamentals of Sociology, Basic Concepts in Sociology, Social Structure and Change in India, Elements of Social Psychology, Sociology of Work, Life Skill Education, Culture and Society, Social Pathology and Media and Society are substituted.

Out of the total of Sixteen Courses, four are at the application level, which come 30% of the total syllabus.

The total credits and instructional hours are maintained without change.

The Board has approved the distribution of marks for External and Internal components of the examination as 75 and 25.

It is also decided to introduce the UGC proposed paper on Environmental Studies in the first semester as an additional core.

The Board has decided to retain the project work in the sixth semester. A viva voce is to be conducted by an external evaluator at the end of the Sixth Semester.

NOTE OF THE BOARD OF STUDIES - ZOOLOGY

Board of Studies held on 20.3.2015 has decided to make the following changes in the UG programmes:

- Major swapping between the first and second-year syllabus to create an interest to the beginners in UG Zoology programme.
- Study of non-chordates extended to the first two semesters, as to study diversity of the group is not possible in a single semester.

- Perspectives of science also aligned with the core course I, Biodiversity -Nonchordata I, to give a basic idea on taxonomy and related sciences.
- A new Course, Applied Zoology is introduced in Semester 4 to create an interest in the entrepreneurship aspect of the subject, by replacing Biodiversity- Chordata which is moved to semester.
- A new module, research methodology is added to the core course12, General Informatics, Bioinformatics, Biostatistics and Research Methodology in sixth Semester.
- Introduction of new practicals and methods in respective core courses, which suit the present time.
- 7. Introduction of compulsory field study and related works in Zoology UG programme.
- Addition of relevant topics and deletion of irrelevant and outdated topics from all relevant semesters in sixth semester.

The academic council approved the syllabi and curricula under the Choice Based Credit and Semester System (CBSS) for all the above programmes.

Sub: Approval of syllabi for New M. Phil Programmes and M A Sociology

Note to the academic council: -Syllabus approved by the respective BoS for M.Phil (Economics, Physics & Commerce and MA Sociology will be presented by the Department Heads and the same is submitted for the approval of Academic Council.

Master of Arts in Sociology

The Sacred Heart College, Thevara (Autonomous) proposes to offer a Postgraduate Degree Programme in Sociology with a total of nineteen Theory Papers, a Dissertation and an Internship. In addition to theoretical learning, the course also aims at field-based interactions and exposure activities.

This programme is devised to provide the students a sound theoretical base for the understanding of contemporary social phenomena, with equal importance to classical and contemporary theories on one hand, and a number of special areas of academic topics on the other. It offers a total of three papers on Sociological Theories, and one paper each on areas such as Social Research Methodology and Social Psychology, besides a substantial number of papers which aim at detailed understanding of the diverse realities and issues of Indian Society. Papers on Contemporary social issues such as Globalization, Social Movements, Gender Consciousness, Environmental Crisis and Crime, provide in-depth theoretical as well as empirical insight to the learners.

The papers on Research Methods, Social Psychology and Counseling, Statistics etc. enhance practical skills of students in Field Work, Statistics and SPSS. The students are expected to do an internship with an NGO during the second semester.

In the third semester, the students work on a Dissertation on a topic of specialization under the guidance of the supervising faculty.

Altogether this program is devised as having a total of twenty credits in each semester during the first three semesters and fifteen credits in the final semester.

Note: The Academic council may entrust a subcommittee to scrutinize the syllabus and curriculum to ensure that they match with the stipulations of UGC in this regard so that the proposed programmes may validly substitute the need to undergo course work for Ph. D, before submitting the same for approval with the University.

Item No: 6.

Sub: Introduction of UGC mandatory course – Environmental Studies as per the Supreme Court directive - Approval

Note to the academic council - The ministry of Human Resource Development has instructed UGC as per the directive of Supreme Court, to compulsorily implement a 6-month core course for Environmental Studies for all Undergraduate programmes in all universities and colleges, failing which UGC grants are likely to be withheld.

The curriculum & syllabus stipulated by the UGC in this regard are submitted to the Academic Council for approval.

Item No: 7.

Sub: Review of autonomy

Note to the Academic Council: -

- All statutory bodies have been formed and have started functioning regularly, viz., Governing Council, Academic Council, BoS (20 nos), and Finance Committee. Except for UGC representatives to GC, all other nominations on the part of Government and University have been obtained. So far two governing council meetings, two Academic Council meetings, two Finance committee meetings and at least one BoS meeting of each board were held.
- 2. The Exam manual was duly submitted. The conduct of exams was performed with some amount of strain, however, flawlessly accomplished. It was a great feat to conduct the exams almost totally in accordance with the plan and bring out results in time.
- 3. It was found that the expenditure involved in the conduct of exams far exceeded the income generated through exam fees. The matter was presented before the PTA general body, and it has agreed to a reasonable hike in the fees to accomplish the task wef. 2015-16 academic year.

- 4. It is also proposed that the Academic Council makes a recommendation to the authorities concerned to a) permit the college to fix exam fees at a level that would make the conduct of exam without financial loss and b) request the state to provide some special grants for the promotion of autonomy in aided colleges, especially for the conduct of examination.
- University has constituted a high-power committee to monitor the functioning of Autonomous colleges and has articulated a consensual understanding on identified areas of operation.
- 6. Some strain is felt by the teachers on account of new tasks like that of identifying question paper setters, external examiners, designing curriculum and syllabus and the overlapping of routine tasks of examination by the University
- 7. In the light of review of PG curriculum, the chairmen of the various boards have proposed that it be made mandatory to draft and append a research paper according to the guidelines of Heartian Journal of Pure and Applied sciences (for Science subjects) and SH Research Journal – Humanities & Business Studies (for humanities and Commerce) along with the MSc dissertation from 2013 admission onwards. The proposal is submitted to the AC for approval as part of the curriculum for all PG programmes.

Item No: 8.

Sub: Conduct of Examination 2015-2016 and Related Matters

Note to the Academic council: -The following proposals are presented below for the approval of the Academic council.

- From 2015 admission onwards, the minimum percentage of marks for a pass in postgraduate (PG) examinations for internal as well as external evaluations shall be 40.
 A student fails for a course if he/she fails either for internal or external evaluations.
- No moderation shall be given to the students for a pass in the examinations from 2015 admission onwards.

- If a student fails for a course, the grade point for the course shall be zero ('0') instead of 4.
- In the mark list of students, the Semester Grade Point Average (SGPA) of each semester and the Cumulative Grade Point Average (CGPA) up to the semester shall be shown.

Sub: Admission 2015 – 2016 Review of the preparation

REGULATIONS FOR PG ADMISSION-2015-16

- Admissions to all PG programmes will be based on the marks/grades of the optional subjects obtained up to the fifth semester examination of the respective programmes and the marks obtained in the entrance examination conducted by the college.
- For calculating the index mark for ranking, marks obtained up to the fifth semester will be standardized to 800 and added to marks obtained in the entrance examination standardized to 800.
- 10 marks will be awarded as bonus marks to students who pass out of Sacred Heart College, Thevara.
- Bonus marks will be awarded to NCC/NSS/Ex-service men candidates as per existing Government/University rules.
- Admission to the PG programme shall be provisional subject to the candidate satisfying the eligibility criteria as laid down in the prospectus prior to the notification for the First End Semester examination.

Item No: 10.

Sub: Any other matters, with the consent of the Chair.

- M. Sc. in Environment Science Special interdisciplinary committee appointed for the purpose has proposed a new curriculum for the interdisciplinary programme in Environment Science.
- The main aim of the Programme is to familiarize the students to develop skilled human resources for conservation of nature, pollution prevention, sustainable utilization and management of natural resources for development. The Programme, therefore, envisages human resource development in environmental management through education and research who could be used in future for imparting consultation/training to personnel of NGOs, industries, institutions and public.
- A Programme like this is inevitable in view of the need for a multi-disciplinary approach to analyze complex environmental problems, the arrival of substantive environmental laws requiring specific environmental protocols of investigation and the growing public awareness of a need for action in addressing environmental problems.
- Through environmental education they can gain knowledge to handle the fundamental issues leading to local pollution. Education is a sort of investment that turns into a valuable asset over a period of time. Tomorrow's leaders need to be equipped for tomorrow's challenges, and we must adequately prepare our children for the future they will inherit. That requires a commitment to providing children with environmental education that helps them become educated leaders of tomorrow. Students must be encouraged to understand their surroundings and a framework for action plan must be formulated. The Programme also envisages imparting the required skills and expertise to handle the associated challenges. Hence the main focus of the study would be to impart knowledge, create awareness, inculcate an attitude of concern and provide necessary skill to handle the environment and environmental challenges through research and learning.
