

THIS AGREEMENT "Agreement") is dated 20th day of November 2018 BETWEEN

PARTIES

- (1) **Rajesh James** of Sacred Heart College, Thevara, Kochi, Kerala, 682013 India and **Sathyaraj Venkatesan** of Office # 310, Lyceum Building, National Institute of Technology Trichy, 620 015, India (the "Volume Editor" which expression shall, where the context admits in the case of an edited or co-edited work, mean the volume editor or editors as applicable and which shall, where the context and this Agreement admit, include the Volume Editor's assigns, heirs, executors or administrators); and
- (2) **BLOOMSBURY ACADEMIC**, an imprint of **BLOOMSBURY PUBLISHING INC.** of 1385 Broadway, 5th Floor New York, N.Y. 10018USA (the "Publishers" which expression shall where the context admits include any publishing imprint subsidiary of or company associated with the Publishers and Publishers' administrators assigns or successors in business as the case may be).

BACKGROUND

- (A) The Volume Editor is the original editor of, and owner of the copyright the Volume Editor's Part of the Work provisionally entitled:

"India Retold: Dialogues with Independent Documentary Filmmakers in India" (the "Work")

the details of which are more specifically described in clause 1 below.

- (B) The Publishers are publishers of books and book related materials (including, but not limited to electronic books and other digital products) and the parties have agreed that the Publishers shall publish the Work on the terms and conditions set out below.
- (C) All capitalized terms shall have the meaning ascribed to them in Appendix 1 hereof (the "Definitions") or as otherwise defined in the Agreement.

OPERATIVE PART

1. DESCRIPTION OF THE WORK:

Working Title: India Retold

Working Subtitle: Dialogues with Independent Documentary Filmmakers in India

Extent / Word Count: approximately but not more than 80,000 words. The word limit shall include any notes, bibliography and other preliminary and end matter of a character and extent agreed by the Publishers.

Delivery Date(s): July 15, 2020

Failure to meet the above-mentioned Delivery Date(s) might result in cancellation of the Agreement in accordance with Clause 4.6 herein.

Abstracts and Keywords: The Volume Editor agrees to supply the Publishers with an abstract and keywords for the full text of the Work, and a separate abstract and keywords for each chapter.

Index: The Volume Editor agrees to supply the Publishers with an Index within three (3) weeks after receipt by the Volume Editor of page proofs or other material from which the Index can be generated. If the Volume Editor declines or fails to do so, the Publishers may prepare the Index and shall be entitled to be reimbursed by the Volume Editor, or at the Publishers' discretion to deduct from any sum due to the Volume Editor, the cost of such preparation.


33.3 Both parties submit to the exclusive jurisdiction of the Southern district of New York in relation to any dispute concerning this Agreement, but the parties are also entitled to apply to any court worldwide for injunctive and other remedies in order to protect or enforce their Intellectual Property Rights.

33.4 The parties irrevocably agree that the courts of the Southern district of New York shall have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this Agreement or its subject matter or formation (including non-contractual disputes or claims).


34. NO INJUNCTIVE RELIEF


