Service charges are payable, in advance, if the charges are not paid by the start of the Service period, the contract will automatically stand terminated and service will cease immediately.

1) Scope of Service:

Align Infotech agrees to provide the following services under the agreement, to keep the systems in good working order:


- a) Scheduled preventive service at the start of Services period by Align Infotech.

2) Terms:

7) Payment terms:



8) Change of location:

12) Change of Company:


