manuscript, and the grant number must be clearly mentioned.

p) For major projects, the sanctioned fund shall be released in three installments: 40% as the

initial installment, 40% upon completion of the first year subject to the submission of a

satisfactory progress report along with the Statement of Expenditure (SE) and Utilization

Certificate (UC), and the remaining 20% after the submission of the final project report with the

corresponding SE and UC. For minor projects, the fund shall be released in two installments:

70% as the initial installment and the remaining 30% upon submission of the final project report

along with the SE and UC.

q) In case of the failure to complete the project within the stipulated period or failed to publish

the research outcome in a scopus/web of science the investigator (s) is/are bound to pay back

the entire amount of the project to the institution with 12% interest.
