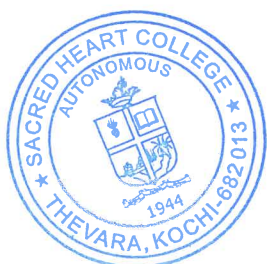

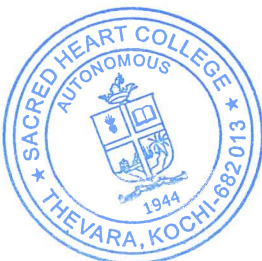

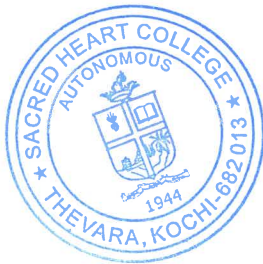
Conditions:-

1. Sale of Tenders:- Tender forms can be had from the College Office, Sacred Heart College, Thevara, Kochi 682013
2. The tenders should be submitted in sealed envelopes and superscripted with "Tender No.**A1/LAB/TENDER/2025-26**" and Tender for supply/installation of at Sacred Heart College, Thevara, Kochi 682013.
3. Last date of receipt of the tender will be 01/12/2025 at 3.00 pm. The tenders received after the last date and time specified above will be rejected. The tender offers shall be accompanied by an Earnest Money Deposit (EMD) in the form of crossed demand draft drawn in favour of "THE PRINCIPAL SH COLLEGE" payable at Ernakulam. The firms which are exempted from furnishing EMD should produce an attested copy of relevant authorized document for verification. The tenders without EMD or authorized documents exempting EMD will be rejected summarily. SSI units registered with the Store Purchase Department, Kerala or with National Small Scale Industries Corporation Ltd., New Delhi only are exempted from the payment of EMD.
4. The bidder to whom tender has been awarded should deposit a security amount of 5% of the cost as demand draft in favour of 'THE PRINCIPAL SH COLLEGE' and an agreement in Kerala stamp paper worth **Rs.200/-**. The security will be released only after satisfactory performance during the warranty period.
